Conclusion of significant agreement of a net value of PLN 44,669,799.75 for CONSTRUCTION WORKS under the project: "Conversion of the voivodeship road No. 152 at the Świdwin – Połczyn Zdrój section – stage 1"

Legal background: Article 17.1 MAR – confidential information.

Report contents:

ONDE S.A. Management Board (Issuer) informs that the Company ONDE S.A. on 7 March 2022 concluded an agreement for construction works under the project: "Conversion of the voivodeship road No. 152 at the Świdwin – Połczyn Zdrój section – stage 1" under terms and conditions specified below:

- 1. Investor: Województwo Zachodniopomorskie Zachodniopomorski Zarząd Dróg Wojewódzkich in Koszalin;
- 2. Estimated contract value: PLN 44,669,799.75 net
- 3. Subject of the Contract: Conversion of the voivodeship road No. 152 at the Świdwin Połczyn Zdrój section stage 1
- 4. Final deadline for contract performance: 540 of a date of concluding the agreement.
- 5. Payment terms: partial invoicing, payment within 30 days.
- 6. Penalties and liability:
 - for a delay in performance of works covered by the order 0.2 % of the total gross price for each day of delay;
 - for a delay in removal of defects found during final acceptance 0.05 % of the total gross price for each day of delay past the date specified for removal of defects;
 - when works covered by this agreement are performed by an entity other than Issuer a penalty in the amount of 1 % of the total gross price;
 - for appointing as the Construction Site Manager a person other than specified in the agreement in the amount of 1 % of the total gross price;
 - for termination/withdrawal from the agreement for reasons attributable to the Contractor in the amount of 10 % of the gross remuneration.

The penalties do not differ from market conditions for agreements of this type.

7. Guarantee periods: quality guarantee for performed works and materials used, for a period of 7 years, with a guarantee for road surface marking for a period of 4 years.

The agreement provides for price indexation after 12 months from a date of conclusion of the agreement.
